FY 2018 Fringe Rates Schedule

The following is the FY 2018 composite fringe rate schedule for use in proposals for UH employees. The non-UH rates are based on the approved State of Hawaii fringe benefit rates for FY 16 (State of Hawaii Department of Budget and Finance Memo No. 16-05), except for the Pension Accumulation fringe rate which reflects the increased rate pursuant to Act 17, SLH 2017¹. Updated State of Hawaii rates for FY 17 and FY 18 are not yet available. The UH rates reflected below have been approved by US DHHS for FY 18. Refer to RCUH HR Policies No. 3.510 for estimated fringe benefit rates for RCUH employees. If the actual fringe rate for an employee is known, it should be used instead.
