



United States (US) Export Controls Classification Certification

Background:

The University of Hawai'i (UH) is requesting that you, the vendor/manufacture of the product(s) being procured, supply the classification pertaining to the appropriate export regulations ([EAR/ITAR](#)) for each product on your quote/invoice. Because UH may export your product or disclose technical data about your product to a foreign national, which is known as a "deemed export", your assistance in furnishing an accurate ITAR Category or EAR ECCN classification will ensure that our university is compliant with EAR/ITAR regulations. If your organization is outside of the US and you do not use US export classifications, you may use the international [Wassenaar Arrangement's](#) Control List for identifying the classification.
